to the following:		

1. The mare owner will pay a breeding fee of \$1200.00 (includes first collection fee) payable as follows: A booking fee of \$600.00 payable with this contract and a copy of the mares registration papers. Booking fee is non-refundable.

The balance of the Breeding Fee \$600 and all unpaid board and veterinary fees must be paid in full before the mare is released to the owner if applicable.

a. Cooled Semen can be shipped by FedEx Overnight Delivery Only, upon payment of the breeding fee and shipping costs. The mare owner will notify the Piedmont Equine Associates and Elizabeth Clavette when the mare has been ultra-sounded by a veterinarian. Please give us at least 24 hour notice for all collection and shipments. Piedmont Equine only collects Monday, Wednesday and Fridays. Confirm or cancel by 5pm the night prior. Shipping containers need to be returned within 4 days or \$100 late fee will be charged to the mare owner.

If secondary shipments are required, then all collection cost and shipping cost of semen will be billed to the mare owner (Collection fee of \$365 and all shipping fees paid before semen is shipped).

- 2. The mare must be halter broke, healthy and in sound breeding condition if staying at breeding facility.
- 3. The mare owner agrees O'Lenas Little Badger will not be responsible for accident, sickness, or death of the mare and/or her foal. O'Lenas Little Badger will exercise judgment in the care and supervision of the mare and/or foal. It is also understood that the mare owner will not be responsible for any disease, accident, or injury to O'Lenas Little Badger Stallion.
- 4. Live foal guarantee: A live foal is defined as one that will stand and nurse. If foal is born dead, mare owner agrees to furnish the stallion owner within 7 days a veterinarian's certificate describing the occurrence. In such a case return privilege will be available for one year only. Rebreeds must pay the rebreed chute fee and any shipping charges applicable. If the mare aborts or fails to conceive, she may return during the current breeding season. If it becomes too late to re-breed a mare during the current season, she may be bred the following year ONLY, provided a re-breed collection fee of \$250 and all shipping fees are paid and/or all relevant shipping charges. If the mare owner fails to rebreed the mare the following year, then all fees become forfeited, the right to rebreed is cancelled and the stallion owner is released from all further obligation of this contract, unless otherwise agreed in writing and signed by both parties.
 - * Owner must disclose any previous breeding problems to the stallion owner.
 - * Have a pre-breeding check performed on the mare by a veterinarian 30 days prior to breeding.

- *During the pre-breeding check, the veterinarian must perform a uterine ultrasound and a uterine culture of the mare. The culture must come back clean and clear before breeding to O'Lenas Little Badger.
- *Deworm and Vaccinate mare at least 14 days prior to breeding.
- * Required vaccinations are: West Nile, Eastern and Western Equine Encephalomyelitis, Tetanus, Influenza, and Rhino (EHV-1 and EHV-4)
- * Mare owner is required to have an ultrasound pregnancy check performed by a licensed veterinarian after being bred by the stallion and the results shall be communicated to the stallion owner. It is recommended that the pregnancy check is performed 14-18 days after breeding to ensure twins are not present. Any mare not ultra-sounded with-in 18 days after being bred shall make the "Live Foal Guarantee" Null and Void.

Mare must be re-checked and confirmed pregnant at 25-35 days into gestation.

- 5. It is further agreed that should "O'Lenas Little Badger" die or become unfit for breeding, then this contract shall become null and void, and the breeding fee, less the booking fee, shall be refunded.
- 6. A copy of the mare's registration papers (and lease agreement if applicable) must accompany this contract.
- 7. This contract shall not be assigned to or transferred by either party, without the expressed consent of the other party.
- 8. This agreement shall be binding upon both parties when executed by the owner and on behalf of O'Lenas Little Badger

Upon signing this contract, all conditions are agreed upon between stallion owner and mare owners (or agent)
